# Legal Responsibilities for Community Initiatives for Program Development

#### Major Activities:

The Youth and Family Services Division manages community based programs to prevent child abuse and delinquency. Additionally, the Texas Runaway Hotline is managed from this Division.

- Community Youth Development Program This program assists communities in designing comprehensive approaches to support families and enhance the positive development of youth. Using legislative appropriations, grants are made available for developing juvenile delinquency prevention approaches in communities with high incidence of juvenile crime. Eleven communities are being served.
- ◆ Services to At-Risk Youth (STAR) Program These services are offered to youth ages 7-18 who are runaways, truants, youths experiencing family conflict or involved in delinquent conduct (but have not been adjudicated), and their families. Contracted community agencies offer family crisis intervention, short-term emergency residential care, individual and family counseling, and an array of supportive services.
- ◆ Texas Families: Together and Safe Grants are allocated for Family Support services to community based preventive programs. The services are designed to alleviate stress and promote parental competencies and behaviors that will increase the ability of families to successfully nurture their children; enable families to use other resources and opportunities available in the community; and create supportive networks to enhance child-rearing abilities of parents.
- ◆ Texas Runaway Hotline Hotline staff and volunteers work closely with social service agencies and juvenile delinquency prevention programs. Their goal is to provide callers with 24-hour crisis intervention and telephone counseling; information and referral for callers in need of food, shelter and/or transportation home; conference calls to parents and shelters; and a confidential message relay service between runaways and parents.
- Gang Activity Prevention The program's objectives are to reduce the risk factors that may lead to gang involvement and students dropping out of school. Activities that are provided encourage parental involvement, educational enhancement, cultural and social enrichment activities, drug prevention education, and supportive guidance.

The Community Initiatives Division develops and implements special projects and initiatives in the agency's three program areas: Child Protective Services, Child Care Licensing, and Adult Protective Services. This includes Research and Evaluation staff who monitor federal and foundation funding opportunities and match ideas for innovation in service delivery to the types of projects federal agencies or private foundations want to fund.

- ◆ Community Partners Community Partners is a public/private partnership that develops local boards to support Child Protective Services staff by creating projects such as Adopt-A-Caseworker and Rainbow Room. Adopt-A-Caseworker focuses on finding a sponsor to meet caseworker needs for resources for clients. The Rainbow Room stocks emergency items needed by children and families such as diapers, formula, clothes, toys, and cleaning supplies.
- Young at Heart Young at Heart is an intergenerational program that encourages older Texans to volunteer and spend time with young children in child-care settings. A grant for Volunteers in Service to America has enabled the agency to implement the program. The project includes recruitment, training, media materials, and volunteer recognition.
- ◆ Family Outreach Family Outreach is an all volunteer organization that works to recruit successful parents to work with at-risk families under the supervision of a PRS case manager. Services by trained volunteers include services to at-risk families, parenting classes, "warm lines" for parents in crisis, and other services as determined by the local center.




## Services to Runaways and At-Risk Youth (STAR)

The Services to Runaways and At-risk Youth (STAR) program was developed to assist local communities in serving youth who often fall between the cracks of the service delivery system. Their problems are not severe enough to receive services from traditional systems such as Child Protective Services or Juvenile Probation. Therefore, the STAR program has established 32 contracts around the state with local agencies who make crisis counseling, emergency short-term residential care, and skill training available to runaway and at-risk youths and their families.

#### Runaway and At-Risk Youth Receiving Counseling and Residential Services Fiscal Years 1993–97




#### Major Office Locations of STAR Program by County Fiscal Year 1997
