Performance Based Contract Demonstration Project Update -

- 36 active providers involved
- 4 segments of enhancements
 - o Remedies
 - Incentives to providers
 - Starting a sub-committee in August 2016 to work on developing incentives;
 - Goal is to have new incentives drafted in December 2016 in preparation for legislative session
 - o Predictive analytics
 - Identifying high risk children (via child characteristics, records review, interviews with legal parties) & contract monitoring providers to ensure children are getting the services needed to achieve safety, well-being, permanency
 - o Performance measures (IMPACT data, self reported data, setting targets)
 - 12 Providers involved in sub-committee to set targets (7/19/16 first meeting)
 - By 9/1/16, goal is to have new performance measures drafted

- Make sure terms are defined within performance measures
- Scorecard by end of FY 17, full implementation in FY 18

PPP Advisory Committee Status & Update -

- Reviewed Sunset Advisory Commission Staff Report
- Agency now has 6 active advisory committees
- Rules were adopted for all 6 advisory committees
 - o 24 member limit, excluding DFPS staff
 - o Section I of rules requires PPP to adopt bylaws
 - o PPP bylaws were drafted in 2014 but never adopted
 - Need to edit drafted bylaws (whole group will participate in editing bylaws)
 - o Goal is to have bylaws adopted at next quarterly PPP meeting

Family First Prevention Services Act -

- Congress proposed federal legislation to sharply reducing the use of congregate care (including Emergency Shelter, Basic GRO's, RTC's) to 2 weeks only; anything over 2 weeks states can no longer receive Title IVE funding for payment of placement
- Exception includes children placed in a Qualified Residential Treatment Program (defined in statute)
- Will likely be voted on by July 15th before Congress breaks
- DFPS is looking at the impact on the current children in congregate care & possible practice changes if act passes into law – PPP would like to review data/analysis of the impact
- Regardless if the act passes, need to see the act as how congress will be looking at foster care differently
- 5 states are actively voicing opposition to the act, TX is one of them, mainly related to lack of infrastructure
- Handouts presented will be sent to PPP members
- Encouraged DFPS to reach out to national organizations for their take

Foster Care Redesign Region 3b Update -

- July 13th release of ACH/OCOK's Progress Report on FCR in region 3b
- Highlighted recent CANS results which are promising, lessons learned, future needs
- George Cannata is the new RD in Region 3
- Day to day wins connect to front line staff

Region 2 RFP Status -

- Approved for release by HHSC Commissioner
- Release should occur at end of this month
- Typical RFP release takes approximately 5 months

Foster Care Redesign (FCR)- Education and Communication Campaign –

 Need to develop messaging to the media/communities across the state in a more positive, planned approach as to what FCR is about, successes of FCR

- Possibly plan a quorum at the Capital and in a rural area about foster care redesign, include a panel of key partners who can speak to their experience with foster care redesign
- Would like to have a larger commitment & plan to rolling out FCR at a much faster pace across the state
- FCR Implementation Plan required by Sunset is complete and is being routed for approval
- 7 members of PPP will form a sub-committee to develop a communication campaign

Capacity Building Initiatives Update -

- DFPS needs increased capacity everywhere in the state for children of all ages
- Treatment Foster Care RFI released in May; received 15 responses; RFP will be posted in early fall 2016
- Integrated Case Management RFI released & only received 1 response to date specific to population of children with the highest needs (i.e. children in psychiatric hospital)
- Sub-acute care enrollment is still open, but no one has enrolled yet hearing that there is no incentive for providers to enroll; Red River has expressed interest in enrolling
- Reaching out to other providers in neighboring states to assist with placement; also talking to providers that currently don't contract with DFPS
- DFPS is holding "call to action" meetings in each region across the state to discuss capacity needs in specific areas

Occupancy Analysis -

- Power point presented
- First look at occupancy data broken out by FCR catchment area (17 areas total)
- Short term analysis
- Using this data in "call to action" meetings in each region across the state
- Recommendations on keeping children closer to home:
 - Utilizing some sort of matching software like eCAP (OCOK uses this)
 - o Minimize placement disruptions; look at trends in disruptions in particular homes & address issues that may be happening in certain homes
 - o Looking at internal placement processes
 - o Intentional efforts to reach out to foster parents to determine & address capacity issues from their point of view
